- 3. As described in the prospectus filed by the Issuer with the Securities and Exchange Commission, upon the closing of the initial public offering and the underwriters' exercise of the additional shares, the Issuer redeemed the Common Units from the Reporting Person.
- 4. A portion of the Common Units vested immediately upon issuance. The remaining non-vested Common Units vest as to 1/36th of the underlying shares in 25 substantially equal monthly installments, commencing on September 30, 2021, such that the Common Units will become fully vested on September 30, 2023.
